The bidding documents will be issued to the interested firm/contractors on submission of written request on original letter head from the owner of the firm or their authorized representative having valid special power of attorney on the stamp paper duly attested by Oath Commissioner and on payment of non-refundable cost of tender price mentioned against each work, through call deposit/pay order on any scheduled bank in favor of **Karachi Development Authority** and bidding document can also be downloaded from the SPPRA website (<https://ppms.pprasinhd.gov.pk/PPMS/>) with tender fee mentioned as above by hand/postal tender will not be considered.
4. The bid security equal **5%** of Bid Amount in shape of pay order from any scheduled bank in favor of **Karachi Development Authority** must be enclosed with tender documents; otherwise the tender will be rejected.
5. The contractors must mention their complete and correct present / postal address in tender documents and quoted the rates both in words and in figures incomplete / conditional tenders will be not accepted.
6. If any fake documents are found then the tender is liable to be rejected / cancelled without any compensation with penalty as per rules.

- f. Valid PEC 2020 and Category relevant field of specialization codes (where applicable).
- g. Affidavit / Undertaking regarding Firm never been black listed **OR** not involved in any Court Case/Litigation with any Government/Semi Government Department.
- h. Copy of CNIC
