

4. The bid security equal **5%** of Bid Amount in shape of pay order from any scheduled bank in favor of **Karachi Development Authority** must be enclosed with tender documents; otherwise the tender will be rejected.
5. The contractors must mention their complete and correct present / postal address in tender documents and quoted the rates both in words and in figures incomplete / conditional tenders will be not accepted.
6. If any fake documents are found then the tender is liable to be rejected / cancelled without any compensation with penalty as per rules.
7. Canvassing in connection of tenders is strictly prohibited and tenders submitted by the contractors who are reported to be involved in canvassing will be liable for rejection.
8. All the tenders will be dropped on as per above schedule up to 11:00 am and will be opened by the Procurement Committee, in the office of the undersigned at 11:30 am in presence of such contractors / parties / firms/bidders who wish to be present.
9. In case, the date of opening declared as a public holiday by the Government, or non-working day due to any reason the next official working day shall be deemed to be the date for submission and opening of tenders at the same time.
10. The procuring agency may reject all or any bids/tenders at any time prior to the acceptance of a bid or proposal subject to the relevant provision of SPPRA Rules 2010 (amended 2019).

- e. Proof of relevant experience and details of at least three works executed/being executed since last 3 years indicating the name of project/scheme/works with cost, date of commencement & completion.
- f. Valid PEC 2020 and Category relevant field of specialization codes (where applicable).
- g. Affidavit / Undertaking regarding Firm never been black listed **OR** not involved in any Court Case/Litigation with any Government/Semi Government Department.
