 - e. Proof of relevant experience and details of at least three works executed/being executed since last 3 years indicating the name of project/scheme/works with cost, date of commencement & completion.
 - f. Valid PEC 2020 and Category relevant field of specialization codes (where applicable).
 - g. Affidavit / Undertaking regarding Firm never been black listed OR not involved in any Court Case/Litigation with any Government/Semi Government Department.
 - h. Copy of CNIC
