1) REVISION OF RATES OF SERVICE CHARGES OF DIFFERENT CATEGORIES OF PLOTS IN SCHEMES & TOWNSHIPS OF KDA.

#### **RESOLUTION NO: 18:**

The recommendations made in the item Note were discussed and resolved to approve the proposal for revision / enhancement of rates / service charges 15% in Schemes & Townships of KDA in all categories of plots, with following amendment in Head No. 11 of Service Charges for (NOC for Sub-Lease on Total covered Area of Commercial Plots/ Flat Sites & Converted Commercial Plots.

#### AT THE TIME OF LEASE:

- If Building Plan is approved by SBCA: The lessee is bound to pay Sub-lease charges at the time of execution of lease.
- If Building Plan is NOT approved by SBCA: The lessee shall submit an undertaking to pay Sub-Lease charges at the time of Approval of Building Plan.

### AT THE TIME OF FORWARDING OF BUILDING PLAN:

- If Commercial Plot/ Flat Site is leased: The lessee is bound to pay Sub-lease charges at the time of Forwarding of Building Plan.
- If Commercial Plot/ Flat Site is NOT leased: The allottee shall submit an undertaking to pay Sub-Lease Charges at the time of Execution of Lease.
